PRESIDENT'S REPORT

The President presented his report as printed in the Annual Report, with reference to the following items

- Thanked Donna for her contribution as the Club Secretary
- Maintenance Ongoing roof issues. Employed Architect to investigate if we can repair for 10 years or should we replace the roof. 10 Builders have been asked and none were interested in quoting.

Ladies toilets are also an issue.

- Thanked Richard Wagstaff and David for cleaning the leaves out of the guttering, and Richard for his continuing property maintenance.
- Club Income is very healthy including \$10,000 from car parking. Nigel expressed his gratitude to those who helped with this.
 - There has also been an increase in numbers of people playing in tournaments, by 6%. Nigel thanked all those who helped him and Jane Sandelin for her work in the kitchen.
- Thank you to Cynthia Clayton for donating another \$1,135 to the Club

- President Nigel's final thanks were to all the Committee and all members for their support.

FINANCE REPORT

The finance report as presented in the Annual report was tabled.

- Treasurer Kim Thompson said this year there was less maintenance and table money was up, increasing from \$27,000 to \$34,500.
- Thank you Cynthia for your donation to the club of \$1,135
- Car parking increased by \$5,000, up to \$11,500, thanks to the Rugby 7's being held in Hamilton.
- Insurance increased from \$4,000 to \$7,000. The building value went up an extra \$1 million, to \$2 ½ million.
- The building quotes are not happening because they don't want to give a 10 year warranty on such a project.
- Profit and Loss Deferred Maintenance fund \$30,000. \$16,000 profit this year and this needs to continue being raised because when the roof fails it will be a huge cost.
 As there were no queries the Treasurer moved the adoption of the report.

President's Report to the Annual General Meeting - November 2019

Membership:

We have 18 new members join the club through the lessons programme and an additional 12 new members joined during the year. There were 9 resignations, leaving our club membership with a net increase of 21.

Maintenance:

Progress has been made on the planning for our roof repairs. We have received a quote and are currently submitting grant applications for funds towards these repairs. We commissioned an *Initial Seismic Assessment* and, based on the analysis, the building has a rating of 85% new building standard. This is very satisfactory for a 45 year old building.

My thanks to Richard Wagstaff who gives many hours completing all the small maintenance jobs around the clubrooms saving the club hundreds of dollars.

There are a number of areas of expenditure for upgrading existing items the committee will need to consider in the coming year.

Tournaments

The club has held 14 major tournaments throughout the year and is scheduled to hold the NZB North Island Pairs in June next year. We are also hosting a new format open grade tournament – a Restricted Open which will cater for players who hold under a certain amount of A and B points. Overall participation has increased in the open swiss and teams tournaments, while the number of members playing in the junior and intermediate tournaments has been disappointing. While many of our members play bridge for social enjoyment, playing in just one or two tournaments each year can improve your bridge skills exponentially, thus your enjoyment of club play.

This large number of tournaments places pressure on the catering team and I acknowledge and thank Jane Sandelin and her group of kitchen helpers for the significant contribution they make to the club. I ask that every member contributes in some way to the tournament organisation as the success of our tournaments contribute

a significant amount of funds for the club's use and assists in keeping our subscriptions at the same level each year.

Sponsorship:

Many thanks to our main tournament sponsors - Craigs Investment Partners, Ryman Healthcare and Urge Coffee and Tea Boutique owned by a club member, Jeffrey Chang and also to our own club members who place advertisements in the membership book. The club is very grateful for this continued support from all our sponsors.

Tournament surplus' and car parking remain our most successful fundraising contributors. I thank Cynthia Clayton for her continued support through the sale of her cards, again contributing to the clubs funds.
