

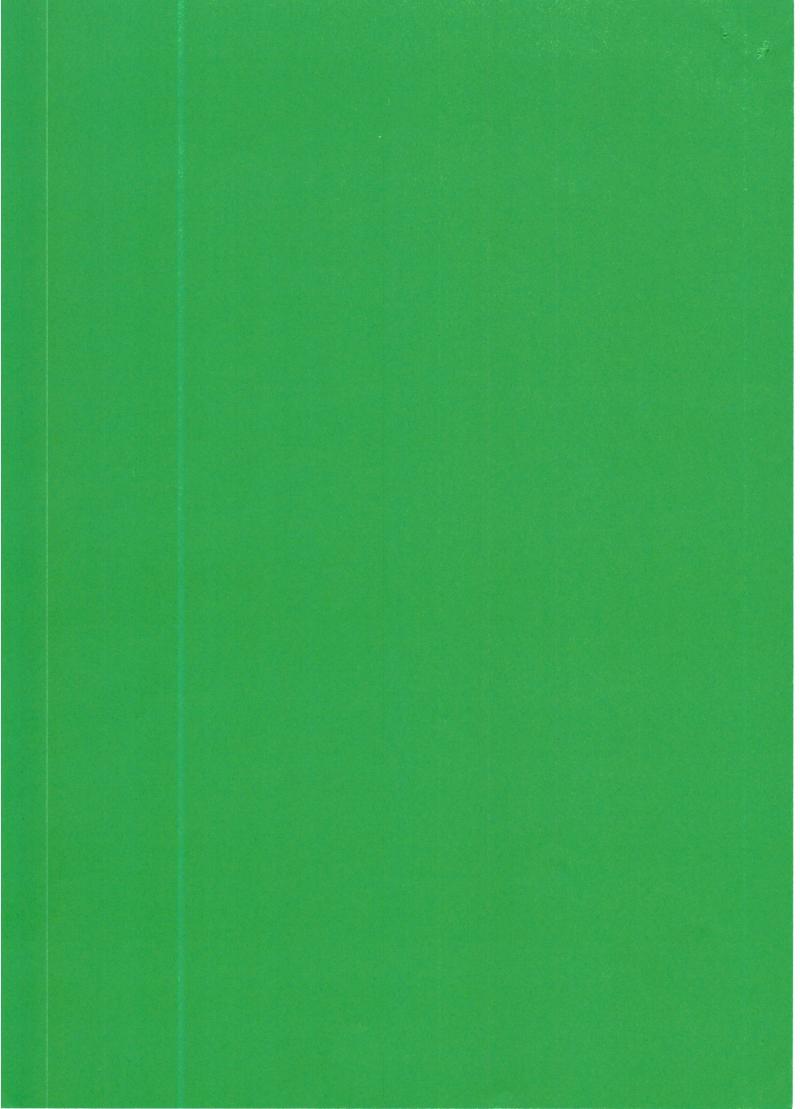

TREASURERS REPORT TO ANNUAL GENERAL MEETING 2025

This has been a successful year for the Hamilton Contract Bridge Club financially with increases particularly in beginner fees, car parking, building hire and interest received.

The efforts of many in running the successful learners lessons this year and following up with an additional session on Thursday afternoons and the excellent assimilation of the night time learners into the Tuesday evening sessions is a large part of our financial success this year. The retention of these learners is essential in growing our membership.

The attached Profit and Loss account show a profit of \$3,806 for the year which is an excellent result given that in the year we have replaced the carpet and faced some additional expenses with regard to building maintenance.

There have been successful raffles run during the year which were initiated to raise money to make improvements to both the men's and ladies bathroom areas. Hopefully we are in a position to carry out this work in the near future.

My role has actually been as overseer of the accounts in consultation with both the committee and Julie, our very efficient office manager. We did utilize some of the S Waymouth legacy to cover the cost of new boards and cards during the year.

Although not shown in these accounts as it did not happen until October, we did raise just over \$2,000 from the Allo Allo show at Riverlea Theatre.
